Invitation of Public Comments

Sub: Proposal for permission for laying of 6" Ø Carbon Steel Gas Pipeline along NH-509 (Old NH-93) from Ch. 17.000 to Ch. 41.150 and from Ch. 41.150 to Ch. 45.750 and One crossing at Ch. 45.600 to develop CGD Network in Moradabad District of Uttar Pradesh State.

The Assistant General Manager, M/s Torrent GAS, Moradabad has submitted the aforesaid proposal for permission for laying of 6" Ø Carbon Steel Gas Pipeline along NH-509 (Old NH-93) from Ch. 17.000 to Ch. 41.150 and from Ch. 41.150 to Ch. 45.750 and One crossing at Ch. 45.600 to develop CGD Network in Moradabad District of Uttar Pradesh State.

- 2. From the submitted proposal, it is seen that as per checklist the Gas Pipe line is proposed 6" Ø Carbon Steel Gas Pipeline (LHS) along the road from NH Ch. 17.000 to Ch. 41.150 (length = 24150m) and from Ch. 41.150 to Ch. 45.750 (length = 4600m) One crossing at Ch. 45.600 (length = 25) (Total applied length = 28775m). Width of available ROW is 25m. Further, it has been mentioned that the ROW in Left as well as Right side from centre line towards increasing chainage/km direction is 12.5m. The project is existing 2-lane. Applicant has proposes Methodology for laying/crossing of Gas Pipeline through open trench and HDD Method. However, if the proposal found in order, permission will be given only through HDD method for executing the work, so that surface can be damaged minimal and work can be executed rapidly.
- 3. As per the guidelines issued by the Ministry vide OM No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained
