The Authorized Signatory M/s Megha City Gas Distribution Private Limited has submitted the proposal for the permission of laying U/G 300mm ø Steel Pipe Line (PSL 2, X-46, 7.1mm THK) from Ch. 58.443 to Ch. 83.030 (RHS) (Total Length – 24587.00M) along NH-509 (Moradabad-Agra Section) at Village-Koil, Tehsil-Gunnaur, District-Sambhal in the state of Uttar Pradesh.

As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
