The Authorized Signatory M/s Megha City Gas Distribution Private Limited has submitted the proposal for the permission of laying U/G 300mm ø Steel Pipe Line (PSL2, X-46, 7.1mm THK) from Ch. 106.260 to Ch. 128.746 (LHS) (Total Length – 22486.00M) along NH-9 (Gajraula-Joya Section) at Nagar Panchayat-Joya, Tehsil-Amroha, District-Amroha in the state of Uttar Pradesh.
