Invitation of Public Comments

Sub: NHAI, PIU - Viluppuram - Proposal for laying of underground Optical Fiber Cable (OFC) on NH-45 along the road from Km.146/600 to Km.146/900 (RHS) and Km.156/750 to Km.157/060 (RHS) and also a crossing at Km.156/750, for a total length of 610m along the NH and one crossing across NH by M/s. Telesonic Networks Limited, Chennai - Approval Requested - req.

- i. The subject proposal is requesting a permission to lay an underground Optical Fiber Cable (OFC) along the NH-45 by trench method of 40mm Dia PLB pipe from Km.146/600 to Km.146/900 (RHS) and 150mm dia RCC casing pipe by HDD method across NH at Km.156/750 in the project stretch of Tindivanam to Ulundurpet section of NH-45.
- ii. M/s. Telesonic Networks Limited, Chennai had given an undertaking to shift the utility line for any work of improvement or repairs to the road, If NHAI considers it as necessary, in the future, it will be carried out as desired by the NHAI at the cost of the applicant within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking to pay rent/fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R Dt.22.11.2016 as and when asked by NHAI.
- iii. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) Dt.22.11.2016, the proposal submitted by M/s. Telesonic Networks Limited, Chennai will be put out in the Ministry's website for 30 days seeking Claims/Comments/ Objections (on ground of public inconvenience, safety, and general public interest) from the day of disclosure in the website.
