Subject: Permission for laying underground Optical Fiber Cable along the NH in the section of Padalur - Trichy of NH-45 from Km 296/400 to Km 308/600 (RHS), Km 310/000 to Km 323/400 (RHS) and Km 313/000 to Km 316/400 (LHS) and across at Km 299/086, Km 305/531, Km 307/531 for a total length of 29.00 Km in the State of Tamil Nadu - Proposal Submitted - Reg.

The Proposal is regarding permission for laying underground Optical Fiber Cable along the NH in the section of Padalur - Trichy of NH-45 from Km 296/400 to Km 308/600 (RHS), Km 310/000 to Km 323/400 (RHS) and Km 313/000 to Km 316/400 (LHS) and across at Km 299/086, Km 305/531, Km 307/531 for a length of 29.00 Km in the State of Tamil Nadu by M/s. Telesonic Networks Ltd, Chennai has submitted to this office by the PD, PIU, Trichy vide letter No. NHAI/PD/TRY/Utility/NH-45/OFC/2021/306 dated 01.03.2021 in accordance with Ministry's latest guidelines dated 22.11.2016.

2) The alignment proposed by M/s. Telesonic Networks Ltd, Chennai along the NH from Km 296/400 to Km 308/600 (RHS), Km 310/000 to Km 323/400 (RHS) and Km 313/000 to Km 316/400 (LHS) and across at Km 299/086, Km 305/531, Km 307/531 of Padalur - Trichy of NH-45 i.e. in a length of 29.00 Km as detailed under:

3) The Right of Way is 60 m in the aforesaid stretch. M/s. Telesonic Networks Ltd, Chennai has proposed to lay the Optical Fiber Cable at the edge of the ROW for a length of 29000 m along NH from Km 296/400 to Km 308/600 (RHS), Km 310/000 to Km 323/400 (RHS) and Km 313/000 to Km 316/400 (LHS) **through Open Trench Method** and across at Km 299/086, Km 305/531, Km 307/531 of Padalur - Trichy of NH-45 in the State of Tamil Nadu at a depth of 1.65 m from the top of the sub grade **through HDD Method** which is in conformity with Ministry's guidelines dated 22.11.2016.


4) M/s. Telesonic Networks Ltd, Chennai has furnished an undertaking to the effect that the applicant will remove the laid OFC line in future if required by NH wing of State Highways Department/MoRTH Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH Govt. of India and any right on the NH land. Further, mentioned that M/s. Telesonic Networks Ltd, Chennai will also restore the surfaces to its original condition soon after removal of the OFC lines.

5) As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the proposal submitted by the applicant will be made available for public comments and the comments is invited within 30 days from the day of uploading.
