- 1). The subject proposal is requesting permission for laying of underground 16" OD 3 LPE Coated pipe with Optical Fiber Cable (OFC) across the NH-227 by HDD Method at Km.94/100 in the project stretch of Kallagam Meensurutti section of NH-227 in the State of Tamil Nadu.
- M/s Indian Oil Corporation Limited, Chennai has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers it as necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
