Chief Officer, Chandwad Nagar Parishad, Chandwad vide letter cited above has submitted Proposal for Laying of 110mm & 200mm dia. HDPE Water Supply Pipeline along NH-3 for approval of the Competent Authority, Highway Administration.

HDPE Water Supply Pipeline from Km. 351.235 to Km. 349.900 on RHS (Length 1.335 Km) & Km. 354.600 to Km. 355.400 on LHS (Length 0.8 Km) (Total Length 2.135 Kms) along NH-3 (Dhule Pimpalgaon Section) at Village Chandwad Tal. Chandwad, Dist. Nashik.
