Chief Officer, Chandwad Nagar Parishad, Chandwad vide letter cited above has submitted Proposal for Laying of 110mm & 200mm dia. HDPE Water Supply Pipeline along NH-3 for approval of the Competent Authority, Highway Administration.

Chandwad, Dist. Nashik.
