Sub: NHAI-PIU-NSK- Four laning of Sinnar to Shirdi Section of NH 160 from Design Ch:0/000 to Ch:50/943 including Sinnar Bypass of 3.375 km in the State of Maharashtra on Hybrid Annuity Mode - Maharashtra Information Technology Corporation Ltd. (DIT Mantralaya) proposal for laying Telecom OFC in stretches from Km. 25.000 to Km. 44.800 (LHS & RHS) (Length 19.800 Km.) on NH-160 - Reg.

Maharashtra Information Technology Corporation Ltd. (DIT Mantralaya) vide letter cited above, has submitted the proposal for laying underground OFC cable along ROW of NH-160 (Sinnar-Shirdi) Section of NH-160 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the laying underground OFC cable is proposed along ROW of NH-160 (Sinnar-Shirdi) Section from Km. 25.000 to Km. 44.800 (LHS & RHS) (Length 19.800 Km.) on NH-160.
