Executive Engineer, Pkg-14, MSRDC, NMSCEL, Mumbai vide letter cited above has submitted proposal for laying 33 KV HT Electrical Line by Aerial Method (RSJ Poles) along NHAI-ROW of NH-3 (Vadape-Gonde) Section of NH-3 for approval of the Competent Authority, Highway Administration.

- 2. From the submitted proposal, it is observed that, the Electrical Line by Aerial & underground Method is proposed along NHAI ROW of NH-3 (Vadape-Gonde) Section from 457.447 to 460.500 (Total Length 3.053 km) on NH-3.
