Sub: NHAI-PIU-NSK-Widening of existing 2 lane carriageway to 4/6 lane divided carriageway configuration for **Vadape-Gonde** (Km 539.5-Km 440) section of NH-3 in the State of Maharashtra - **M/s. Telesonic Network Ltd.'s (Airtel) Proposal for laying OFC using HDD Method from Km. 451.850 to Km. 453.050 (Total Length 1.2 Km) on NH-3 - Reg.**

M/s. Telesonic Network Ltd.'s (Airtel) vide letter cited above has submitted proposal for laying underground OFC cable using HDD Method along ROW of NH-3 (Vadape-Gonde) Section of NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the laying underground OFC cable using HDD Method is proposed along ROW of NH-3 (Vadape-Gonde) Section from 451.850 to Km. 453.050 (Total Length 1.2 Km) on NH-3.

3. As per Para-4 of Ministry Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
