Sub: NHAI-PIU-NSK-Road Safety Improvement Works on Ghoti-Sinnar from Km. 0+000 to Km. 53+500 on NH 160A in the state of Maharashtra-Proposal from MSEDCL for Crossing of 11 KV Underground Cable Line across NH-160A at Km. 17.400, Km. 22.200, Km. 27.700, Km. 31.800, Km. 32.900, Km. 37.100, Km. 41.500, Km. 45.100 & Km. 48.700 (Total 9 crossings) on NH-160A - Reg.

Maharashtra State Electricity Distribution Company Ltd.'s (MSEDCL), Nashik Division, Nashik vide letter cited above has submitted Proposal for Crossing 11 KV Electrical Line along NH-160A for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the crossing of Electric Line is proposed across NHAI-ROW viz. Km. 17.400, Km. 22.200, Km. 27.700, Km. 31.800, Km. 32.900, Km. 37.100, Km. 41.500, Km. 45.100 & Km. 48.700 across NH-160A.

As per Para-4 of Ministry of Road Transport & Highways (MoRTH) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
