Maharashtra Natural Gas Limited (MNGL) vide letter cited above has submitted Proposal for laying Steel + MDPE Gas Pipeline along ROW of NH-3 (Pimpalgaon-Nashik-Gonde) Section of NH-3 for approval of the Competent Authority, Highway Administration.
