M/s. Jio Digital Fibre Pvt. Ltd.'s vide letter cited above has submitted proposal for laying underground OFC cable using HDD Method along ROW of NH-3 (Vadape-Gonde) Section of NH-3 for approval of the Competent Authority, Highway Administration.
