Sub: NHA-PIU-NSK-Widening of existing 2 lane carriage way to 4/6 lane carriageway configuration for Dhule - Pimpalgaon (Km 265.00 to Km 380.00) section of NH-3 in the State of Maharashtra-MSMEDCL's Proposal for 02 no. of Crossings of 11 KV Electrical Cable at Km. 265.000 & Km. 380.000 at Village Arvi, Tal. & Dist. Dhule across NH-3.

Ref: EE, MSMEDCL, Dhule's Lr. No. EE/DHL-R/Tech/No. 28, Dtd. 03.01.2023 received on Dtd. 26.03.2024. Maharashtra State Electricity Distribution Company Ltd.'s (MSMEDCL), Rural Division, Dhule vide letter cited above has submitted proposal for Laying / Crossing 11 KV Electrical Line along/across NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the crossing of Electric Line is proposed across NH-3 within NHA-ROW at Km. 265.000 & Km. 380.000 (Village Arvi, Tal. & Dist. Dhule).

As per Para-4 of Ministry of Road Transport & Highways (MoRTH) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
