The proposal is regarding permission for Erection of 11 KV overhead electrical line along the road from Km.141+200 to km.141+550 (RHS), from km.141+550 to km.141+600(LHS) and across at km.141+550 in Madurai - Kanyakumari section of NH-44 in the State of Tamil Nadu submitted to this office by PD, PIU, Madurai vide Lr.No. NHAI/PIU/MDU/NH-7/Utility/2021/3531, dt.04.12.2021 in accordance with Ministry's latest guideline dated 22.11.2016.

2. The alignment proposed by M/s. Kovilpatti Lakshmi Roller Flour Mills Limited, Coimbatore for Erection of 11 KV overhead electrical line along the road from Km.141+200 to km.141+550 (RHS), from km.141+550 to km.141+600(LHS) and across at km.141+550 in Madurai - Kanyakumari of NH-7 in the State of Tamil Nadu i.e., 1400 m as detailed under;

3. The Right of Way is 65 m in the aforesaid stretch. The proposed Erection of 11 KV overhead electrical line along the road from Km.141+200 to Km.141+550 (RHS), from Km.141+550 to Km.141+600 (LHS) and across at Km.141+550 in Madurai - Kanyakumari section of NH-7.
