Sub: NHAI - PIU - Puducherry - Four laning and strengthening of Pondicherry - Tindivanam Section of NH-66 (Km 0/000 - Km 37/920) in the State of Tamil Nadu under NHDP-III- Requesting permission for laying gas pipe line (200mm dia CS pipe) of M/s East Coast Natural Gas Distribution Pvt. Ltd from Km.0+000 to Km.3+530 RHS (Length 3530m) along NH-66 and crossings at two locations at KM.0+025 & Km.1+130(Total Length 3600m) across NH-66 (Jimper campus to Indira Gandhi Statue Road) in Puducherry U.T - Invitation of Public Comments - Reg.

- 1. The proposal is regarding permission sought by M/s East Coast Natural Gas Distribution Pvt. Ltd to lay gas pipe line (200mm dia CS pipe) on NH 66 along the road from designed ch. Km.0+000 to Km.3+530 (RHS) including with two crossings at KM.0+025 & Km.1+130 for a total length of 3.6 km (Jimper campus to Indira Gandhi Statue Road) in the state of Puducherry U.T. Further, the proposal was submitted to this office by M/s East Coast Natural Gas Distribution Pvt.Ltd vide letter Ref.No.SKN/NHAI/NOC/21-22/02 dated 24.08.2021.
- 2. M/s East Coast Natural Gas Distribution Pvt. Ltd has proposed to lay gas pipe line (200mm dia CS pipe) for a length of 3.6km (from Km.0+000 to Km.3+530).

- 3. M/s East Coast Natural Gas Distribution Pvt.
