Ministry vide circular no. RO/MUM/NHDP-39/2015-16 dated 17.04.2020 (copy enclosed) had issued clarifications on recovery schedule for mobilization advance and IBWCA for HAM projects.

Sub: Interest Bearing Working Capital Advance against unbilled executed work to mitigate the cash flow problems of HAM Concessionaire & EPC contractors and modification in Schedule – H of the EPC Contract- Clarification on recovery schedule for mobilization advance and interest bearing working capital advance for HAM projects reg.

Ministry vide circular No. RO/MUM/NHDP-39/2015-16 dated 09.11.2019 has issued policy guidelines for grant of interest bearing working capital advance (IBWCA) for HAM and EPC projects. This Ministry is receiving request for clarification on recovery schedule of mobilization advance and IBWCA for HAM projects as nothing is stated in this regard in circular dated 09-11-2019.

- 2. The recovery of mobilization advance in the HAM project is generally done along with release of first four grants of 8% of adjusted bid project cost (BPC), due at 20%, 40%, 60% and 75% of project progress (the progress % may vary in different contracts). After issuance of circular dated 09.11.2019, the concessionaire of HAM projects are also eligible for IBWCA after achieving progress of 10%, 30%, 50% and 70% in addition to mobilization advance.
- 2. Doubts have been raised as to whether mobilization advance recovery can be done proportionately at the time of release of IBWCA, In this regard it is clarified that the recovery of mobilization advance shall be as per the relevant provision in HAM concession agreement, unless requested by concessionaire for recovery at the time of release of IBWCA proportionately. However, the executing agency shall ensure due validity of requisite BG till the recovery of same.
