Adverting to the above subject, M/s Telesonic Network Ltd, Bangalore has requested for issue of No Objection Certificate for laying Optical Fibre Cable along NH -275 from Kavu Km.29.750 to Mandoor Km.32.250 on LHS for a length of 2.500 Kms of Bantwala - Bangalore section.

Accordingly, the Assistant Executive Engineer, National Highway Sub Division, Madikeri has submitted the proposal by duly verifying with respect to the condition vide letter cited under reference above.

Hence, the proposal is examined in light of norms laid down by the Ministry's Circular RW NH-33044/29/2015/S & R(R) dated: 22.11.2016. Accordingly the proposal in two sets along with the License Agreement in Original and the rate list issued by the Sub - Registrar, Puttur Taluk, Dakshina Kannada District (Kaveri online) of the respective Circle. The land rent calculated based on the prevailing rates of Sub Registrar Market Value works out to be Rs.30,030-00 for five years License Fee. The amount of Bank Guarantee for a length of 2.500 Kms is Rs.2,50,000-00.

The Agency has submitted the necessary drawings, check lists and Undertaking as per the extant.

The proposal for laying of Optical Fibre Cable by Horizontal Directional Drilling method in town limits as per MORT&H Guidelines from Kavu Km.29.750 to Mandoor Km.32.250 on LHS of NH-275 for a total length of 2.500Kms along with Check list, cross sectional drawings showing the details of carriageway width, ROW distance of the OFC cable being laid from the centerline of the carriageway etc are herewith submitted for approval.
