- 2. The Right of Way in the stretch of NH proposed for laying Electrical Cable line is varying from 25.00m to 37.20m. The carriageway width of stretch from Km 66/475 to 66/870(RHS) of NH-81 is varies from 7.00 to 16.00m. M/s. Sree Jagathguru Textiles Mills (P) Ltd., has proposed to lay the underground Public Utility at edge of the ROW for a length of 395m by adopting open trench method along the National Highway and HDD method across the National Highway.
