- 2. The Right of Way in the stretch of NH proposed for laying underground Sullage pipe line is varies 26.90 to 40.00m. The carriageway width of stretch Km 308/374 to 308/725(RHS) of NH-948 is 7.00m. M/s R.R.HOUSING (INDIA)Private Limited, R.R.Sai Complex, Amsa Layout R.S. Puram, Coimbatore has proposed to lay the underground Public Utility at edge of the ROW for a length of 351m by adopting open trench method along the National Highway and HDD method across at Km 308/374 the National Highway.
- 3. M/s R.R.HOUSING (INDIA)Private Limited, R.R.Sai Complex, Amsa Layout R.S. Puram, Coimbatore has furnished an undertaking to the effect that they will remove the laid Public Utility underground sullage pipe line in future if required by NH wing of State Highways Department, Tamil Nadu/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH, Government of India and any right on the NH land. Further, mentioned that, M/s R.R.HOUSING (INDIA)Private Limited, R.R.Sai Complex, Amsa Layout R.S. Puram, Coimbatore will also restore the ROW surfaces to its original condition soon after removal of the Public utility underground sullage pipe lines. Also, certified that the

proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
