- 2. The Right of Way in the stretch of NH proposed for laying Water pipe line is varying from 16.00m to 41.00m. The carriageway width of stretch Km 276/320 to 277/235,Km 277/700 to 280/010(LHS), Km 281/825 to 282/218(LHS) Km 290/970 to 292/080(LHS),Km292/136 to Km 299/136(LHS)Km 280/776 to 282/000(RHS),Km 295/300 to Km 295/333(RHS),Km 295/800 to 296/044(RHS) of NH-948 is varies from 7.00m to 20.00m.
