2. The subject proposal was submitted on Ministry's website on 03.05.18 and was sent vide this office letter dated 09.05.18 to PWD's office for examination.

3. As per the site plan, fuel pump of Essar is at a distance of about 805m from the proposed outlet as against 1000m specified in the guidelines for divided carriageway. Further the oil company has stated vide letter dated 17.05.18 that there are electric line/ tress in ROW as well as insufficient land at some locations. So it is difficult to construct service road between two retail outlets. Further, the case is meeting all the parameters of the guidelines except for the criteria of distance from adjacent retail outlet for divided carriageway.

Therefore the oil company vide letter dated 17.05.18 has asked this office to consider case as per relaxation in guidelines for access permission along National Highway circulated vide letter no. RW/NH-33023/19/99-DOIII dated 16.03.16.
