Sub: Proposal of grant of access permission to the proposed retail outlet of M/s. Essar Oil Ltd in Km 137+169 to 137+204 LHS on NH-65(NNH-58) in Khasra No. 1203/27 of Village-Nyama, Taluka-Sujangarh & District-Churu in the state of Rajasthan.

M/s Essar ie. the applicant vide letter No. Nyama/May/2018 letter received on 31.05.2018 has submitted a proposal to this office on above mentioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013. Earlier a kacha track existed at 111m at LHS of NH near the proposed retail outlet. The same was examined and it was verified by local administration (Sub-Registrar-Salasar, Churu) that the same is closed and not under any use. The proposal indicating the above status has been forwarded/agreed by PD PIU NHAI-Sikar vide letter dated 15.05.2018. PD PIU NHAI-Sikar vide letter even dated 15.05.2018 has conveyed that the competent authority may consider the proposal to relax the criteria 1.1.1 (ii) of the check-list along with certificate of Navab Tehsildar and Gram sarpanch of gram Kharia Kaniram & Batada Naw.

As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the 2.0 Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

In view of the above the comments from public on above mentioned proposal is invited on 3.0public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in) or as per From A (copy enclosed) on below mentioned address.
