In this regard, we would like to inform that permission for laying of Water Supply Pipe line in this section may be granted to D. W. & S. Department Ramgarh, subjected to the following conditions:

- Concessionaire shall be officially informed by the executing agency before commencement of the work.
- 2. Working drawing along with the detailed plan including work completion dates shall be submitted before commencement of the works within the Project RoW.
- 3. After completion of all works, D. W. & S. Department Ramgarh shall inform to NHAI/HREL regarding same and shall submit the as Built Drawing so that laid Water Pipeline can be traced at any point of time. However, if any execution of road works is required in future, then the Concessionaire, HREL and/or the NHAI, Ministry of Road, Transportation and Highways, Govt. of India shall not be responsible for any damage to laid pipeline.
- 4. Exact location of road crossing shall be shown physically to the HREL representative at the time of commencement of works. Road crossing shall be done through utility duct or cross drainage structures only. If at all this is not possible due to constraint of location, then Trenchless method shall be used for crossing of road. Profile for Trenchless method for respective location shall be submitted before start of Road Crossing. In any case, open trench shall not be permitted across the highway. The road crossing shall be done under the supervision of HREL representative. In any case, top of the Pipe will be at minimum 1.0 meter below the sub grade bottom.
- While adopting trenchless method, suitable encasing shall be provided to carry the highway traffic load and dead load of the carriageway.
- The D. W. & S. Department, Ramgarh shall nominate a responsible person with mobile phone facility for coordinating at site and inform the HREL about the same in writing before commencement of work.
- The D. W. & S. Department, Ramgarh must take all necessary steps during executing to avoid any damage to the road property. In any case, if any of the road facility gets damaged via directly or indirectly, the repair shall be done on the risk and cost of D. W. & S. Department, Ramgarh.
- In any condition, excavated material shall not be stacked over Road surface. No inspection chamber/valve chamber shall be permitted on the pavement surface.
