M/s Reliance Jio infocom limited Kochi, has furnished an undertaking certifying that during the DLP period of completed strengthening work ie., up to 30.04.2022, in case of any damage JDFPL will rectify road surface on urgent nature at their own cost.





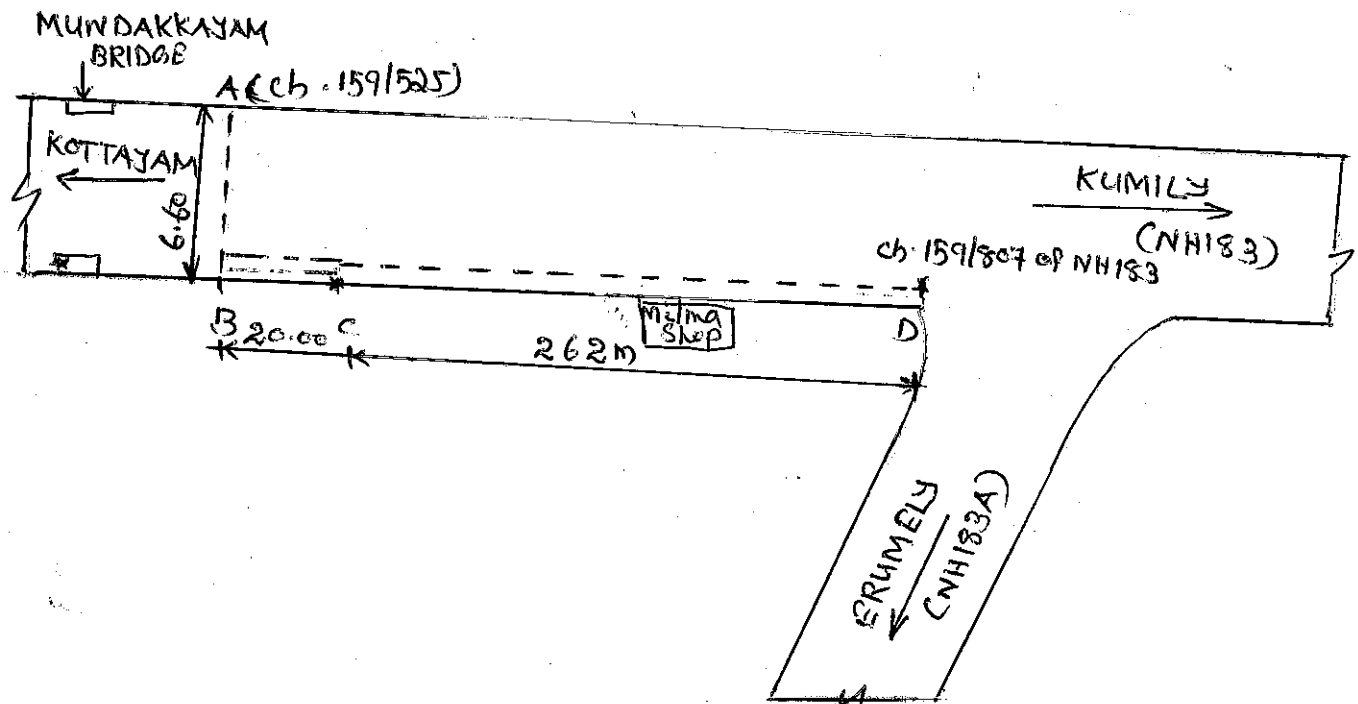
