**Subject: Observing due diligence while uploading notification under section 3a, 3A and 3D of the NH Act, 1956 on BhoomiRashi web portal - regarding.**

Sir,

The undersigned is directed to say that Ministry, in its attempt to move towards total e-governance and avoid delay, has developed a Web Portal - BhoomiRashi, whereby, the land acquisition procedure for the National Highway Projects including processing of all Land Acquisition related gazette notification and payment of compensation to the affected parties, are being done through this platform.

2. However, it has been observed that various notifications processed/uploaded on BhoomiRashi web portal contains certain errors viz. Missing file number in the proposed notification, use of English or any vernacular language or font other than Mangal Unicode as specified by Ministry of Urban Development vide their OM No. O-17022/1/2015-PSP-I dated 30.09.2015 in Hindi version of the notification. As a result, publication of the said notifications gets delayed thereby defeating the purpose of the BhoomiRashi web portal.

3. The matter has been examined and it has been decided by the Competent authority that due diligence may be observed while uploading notification under section 3a, 3A and 3D of the NH Act, 1956 on BhoomiRashi web portal

4. The contents of this letter may be brought to the notice of all officers in your Department for information and further necessary action.


