## INSPECTION REPORT

As per the Endt No.Road Cutting 326A/NH Division/ATO/2018. Dt.31-7-2018 Of the Executive Engineer(R&B) NH Division, Visakhapatnam the Indian Oil Corporation Limited, Visakhapatnam Authorities has submitted the proposals afresh for seeking permission for laying of 16" Paradip Hyderabad Petroleum Product Pipe Line (PHPL) along with 89 mm dia MS Pipe line for OFC cable across NH 326A at Km.35/0-2 by Horizontal Directional Drilling (HDD) Method.

We have jointly inspected the site with reference to the proposal submitted by Indian Oil Corporation Limited. Visakhapatnam and the following points were observed and mentioned below.

1. Indian Oil Corporation Limited, Visakhapatnam has proposed to lay the under ground pipe line across the National Highway NH 326A at km 35/0-2 near the Narayanavalasa village,

2. Indian Oil Corporation Limited, Visakhapamam has proposed to lay the pipe line across the Road for the following stretches as shown below


