

It is pertinent to mention that we are not able to purchase or acquire additional land due to non interest of landowner on both side of proposed fuel station.
  - (ii) A high tension electrical line of double pole structure has been installed within the proposed acceleration lane at Ch. 73.160 after the "in Principle" approval which is also obstructing the proposed construction of A/L lane. In such case if you allowed it may started from 75m instead of 100m.

In view of the above, non-fulfilments of norms or minor deviations may be allowed under Ministry Circular issued vide letter under reference (ii). We shall also provide necessary safety equipments at own cost under your supervision.
