Sub: NHAI, Madurai Region - PIU, Madurai - Operation and Maintenance of Madurai - Kanyakumari section from Km.0/000 to Km.243/170 of NH-7 in the State of Tamil Nadu - NOC for erection of 230 KV Overhead Electrical power supply Line crossing at Km.3+450 in Thuvariman Village - Proposal submitted - Reg.

The proposal is regarding permission for Erection of 230 KV overhead electrical line crossing NH at Km.3+450 in Madurai - Kanyakumari section of NH-7 in the state of Tamil Nadu submitted to this office by PD-Madurai vide Lr.No. NHAI/PIU/MDU/NH-7/Utility/2020/3222, dt.18.12.2020 in accordance with Ministry's latest guideline dated 22.11.2016.

2. The alignment proposed by the Superintending Engineer, GCC, TANTRANSCO, Madurai for Erection of 230 KV overhead electrical line crossing NH at Km.3+450 in Thuvariman village in the section of Madurai - Kanyakumari of NH-7 in the State of Tamil Nadu as detailed under:

- 3. The Right of Way is 60 m in the aforesaid stretch. The proposed Erection of 230 KV overhead electrical line crossing the NH at Km.3+450 in Madurai Kanyakumari section of NH-7. Further, the Superintending Engineer, GCC, TANTRANSCO, Madurai has given undertaking that the vertical clearance is 18.0 m from the FRL (Finished road level) which is in conformity with Ministry's latest guidelines dated 22.11.2016.
- 4. The applicant has furnished an undertaking that they will shift the erected electrical line in future when required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed erection of 230KV overhead electrical line work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
