## Invitation of Public Comments

Sub: NHAI, RO Chennai - PIU - Salem - Permission for laying of a Public Utility - "City Gas Distribution (CGD)" Carbon Steel and MDPE Pipeline with OFC along NH-44 (Sri Nagar - Kanyakumari Highway) in between highway chainage Km 198/457 to Km 201/723 (RHS), Km 201/863 to Km 203/484 (RHS), Km 204/240 to Km 205/232 (RHS) and from Km 203/484 to Km 203/837 (LHS), Km 205/232 to Km 205/300 (LHS) and across at Km 199/293, Km 200/967, Km 203/484, Km 204/240, Km 205/232 in the limits of National Highways, Salem by M/s. Indian Oil Corporation Limited, Salem - Reg.

- 1. The subject proposal pertains to a proposal requesting permission for laying of RLNG Pipeline, of Public Utility City Gas Distribution (CGD) Carbon steel of 219mm dia and MDPE Pipeline of 125mm dia with OFC of 40mm dia along NH-44 (Old NH-7) on Thumbipadi Salem Namakkal section of TN-02 Package for a length of 6300 m length (5879m in RHS & 421 m in LHS) and 5 nos of crossings. The available width of ROW varies from 25m to 62m. and it is proposed lay the pipes and OFC on the utility corridor for a length of 5879 m in RHS and 421 m in LHS and 05 nos crossing viz Km 198/457 to Km 201/723 (RHS), Km 201/863 to Km 203/484 (RHS), Km 204/240 to Km 205/232 (RHS) and from Km 203/484 to Km 203/837 (LHS), Km 205/232 to Km 205/300 (LHS) and 5 numbers of crossings across at Km 199/293, Km 200/967, Km 203/484, Km 204/240, Km 205/232.
- 2. DGM (PJ-CGD), M/s. IOCL, Salem has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
