**Sub:** NHAI, Madurai Region - PIU, Trichy - Permission for the proposal of water supply scheme for added areas (wards 33 to 36) (Sanaripatti) for carrying water from Cauvery river for laying pumping main of 400mm dia DI-K9 from Km 198/270 to Km 203/370 (RHS) along Trichy - Karur section of NH-67 from Manavasi to Veerarakiyam - Proposal submitted - Reg.

The proposal regarding permission for laying of water supply pipeline in water supply scheme for added areas (wards 33 to 36) (Sanaripatti) for carrying water from Cauvery river for laying pumping main of 400mm dia DI-K9 from Km 198/270 to Km 203/370 (RHS) along Trichy - Karur section of NH-67 from Manavasi to Veerarakiyam was submitted to this office by PD, PIU, Trichy vide letter No. NHAI/PD/TRY/Utility/TWAD/NH 67/T-K/2021/244 dated 20.02.2021 & modified proposals Lr. No. NHAI/PD/TRY/Utility/TWAD/NH 67/T-K/2021/930 dated 31.07.2021 (received on 09.08.2021) & Lr. No. NHAI/PD/TRY/Utility/TWAD/NH 67/T-K/2021/1291 dated 25.09.2021 and PD-Trichy email dated 11.10.2021 in accordance with Ministry's latest guidelines dated 22.11.2016.

2) The alignment proposed by the Commissioner, Karur Municipality, Karur for laying of water supply pipeline from Km 198/270 to Km 203/370 (RHS) along NH-67 from Manavasi to Veerarakkiam in the State of Tamil Nadu i.e. for a length of 5100 m as detailed under:

- 3) The Right of Way is varying from 50 m to 180 m in the aforesaid stretch. The Commissioner, Karur Municipality, Karur has proposed to lay water supply pipeline along NH from Km 198/270 to 203/370 (RHS) along Trichy - Karur section of NH-67 from Manavasi to Veerarakkiyam. Further, the Commissioner, Karur Municipality, Karur has given undertaking that the water supply pipeline is proposed to lay by **Open Trench Method** (Km 198/270 to Km 201/950 & Km 202/000 to Km 203/370) & **HDD Method** (Km 201/950 to Km 202/000) at a depth of 1.20 m distance to the casing pipe from the top of the sub grade which is in conformity with Ministry's latest guidelines dated 22.11.2016.
- 4) The Commissioner, Karur Municipality, Karur has furnished an undertaking to the effect that they will remove the laid water supply pipeline in future if required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed laying of water supply pipeline work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
- 5) As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29 /2015/S&R(R) dated 22.11.2016, the application submitted by the applicant will be made available for Public comments and the comments will be invited within 30 days from the day of uploading.
