Sub: NHAI - RO-Madurai - PIU, Trichy - Proposal for laying of Water supply pipeline along NH from Km 1/775 to Km 2/017 (LHS), Km 3/750 to Km 3/972 (LHS), Km 3/972 to Km 4/270 (LHS), Km 4/991 to Km 5/250 (RHS) & across the NH at Km 2/017, Km 3/870 & Km 5/250 at Trichy - Madurai Section of NH-45B for a length of 1288.50m for providing Under Ground Sewerage Scheme to Tiruchirappalli City Corporation under Phase-III works in the State of Tamil Nadu - Proposal submitted - Reg.

The proposal is regarding permission for laying of Water supply pipeline along NH from Km 1/775 to Km 2/017 (LHS), Km 3/750 to Km 3/972 (LHS), Km 3/972 to Km 4/270 (LHS), Km 4/991 to Km 5/250 (RHS) & across the NH at Km 2/017, Km 3/870 & Km 5/250 at Trichy - Madurai Section of NH-45B for a length of 1288.50m for providing Under Ground Sewerage Scheme to Tiruchirappalli City Corporation under Phase-III works in the State of Tamil Nadu submitted to this office by PD, PIU Trichy vide letter No. NHAI/PD/TRY/Utility/TWAD/NH 45B/2021/762 dated 18.06.2021 (Received on 02.07.2021) & Lr. No. NHAI/PD/TRY/Utility/TWAD/NH 45B/2021/1439 dated 19.10.2021 and modified proposal Lr. No. NHAI/PD/TRY/Utility/TWAD/NH 45B/2021/1893 dated 15.12.2021 in accordance with Ministry's latest guidelines dated 22.11.2016.

2) The alignment proposed by the Special Officer & Commissioner, Tiruchirappalli City Corporation, Tiruchirappalli for laying water supply pipeline along & across NH at Trichy - Madurai Section of NH-45B in the State of Tamil Nadu i.e. for a length of 1288.50m as detailed under:

The Right of Way is varying from 45 m to 100 m. The Special Officer & 3) Commissioner, Tiruchirappalli City Corporation, Tiruchirappalli has proposed to lay water supply pipeline along NH from Km 1/775 to Km 2/017 (LHS), Km 3/750 to Km 3/972 (LHS), Km 3/972 to Km 4/270 (LHS), Km 4/991 to Km 5/250 (RHS) and across the NH at Km 2/017, Km 3/870 & Km 5/250 at Trichy - Madurai Section of NH-45B in the State of Tamil Nadu. In this regard, in VUP location at Km 3/972, it is proposed to lay 200mm dia WSPL with 700mm dia MS encasing pipe across Chettiyapatti road intersection for a width of 15m along NH-38 by Open Trench Method at a depth of 1.80 m to the casing pipe from the top of the sub grade. Further, the Special Officer & Commissioner, Tiruchirappalli City Corporation, Tiruchirappalli has given undertaking that the lay of water supply pipeline is proposed to lay along the NH by Open Trench Method at the extreme edge of the RoW & across NH through Trenchless Method at a depth of more than 1.20 m to the casing pipe from the top of the sub grade which is in conformity with Ministry's latest guidelines dated 22.11.2016.

- 4) The Special Officer & Commissioner, Tiruchirappalli City Corporation, Tiruchirappalli has furnished an undertaking to the effect that they will shift the pipe line in required at any time owing to expansion of the road or if necessary by the NH Authority at their own cost & risk without claiming any compensation from NHAI. Also, certified that, the proposed laying of water supply pipeline work will not to damage to other utility, if damaged than to pay the losses either to NHAI or to the concerned agency.
- 5) As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29 /2015/S&R(R) dated 22.11.2016, the application submitted by the applicant will be made available for Public comments and the comments will be invited within 30 days from the day of uploading.
