Sub: NHAI, Madurai Region - PIU, Trichy - Permission for laying of water supply pipeline along NH from Km 124/600 to Km 124/875 (RHS) of NH-136 and across NH at Km 124/875 (RHS to LHS) width 500mm dia pipeline for the Project of Advances Institute for Integrated Research on Livestock and Animal Sciences at Thalaivasal, V.Koot roads in Salem District - Proposal submitted - Reg.

The proposal is regarding permission for laying water supply pipeline along NH from Km 124/600 to Km 124/875 (RHS) of NH-136 and across NH at Km 124/875 (RHS to LHS) in the State of Tamil Nadu submitted to this office by PD, PIU Trichy vide letter No. NHAI/PD/TRY/Utility/TWAD/NH-136/2021/249 dated 22.02.2021 (Received on 01.03.2021) & modified proposal received on Lr. No. NHAI/PD/TRY/Utility/TWAD/NH-136/2021/432 dated 24.03.2021 (received on 29.03.2021) in accordance with Ministry's latest guidelines dated 22.11.2016.

2) The alignment proposed by the Executive Engineer, TWAD Board, RWS Division, Salem for laying water supply pipeline along NH from Km 124/600 to Km 124/875 (RHS) of NH-136 and across NH at Km 124/875 (RHS to LHS) in the State of Tamil Nadu i.e. in a length of 275 m as detailed under:

3) The Right of Way is 23.8 m in the aforesaid stretch. The Executive Engineer, TWAD Board, RWS Division, Salem has proposed to lay water supply pipeline along NH Km 124/600 to Km 124/875 (RHS) for a length of 275 m at the extreme edge of ROW & across the NH at Km 124/875. Further, the Executive Engineer, TWAD Board, RWS Division, Salem has given undertaking that the proposed water supply pipeline will be laid by Open Trench Method at a depth of 1.35 m from the Ground level & across the NH at Km 124/875 through HDD Method at a depth of 1.20 m distance from the top of sub-grade to the casing pipe, which is in conformity with Ministry's latest guidelines dated 22.11.2016.

4) The Executive Engineer, TWAD Board, RWS Division, Salem has furnished an undertaking to the effect that they will remove the laid of water supply pipeline in future if required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed laying of water supply pipeline work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

5) As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29 /2015/S&R(R) dated 22.11.2016, the application submitted by the applicant will be made available for Public comments and the comments will be invited within 30 days from the day of uploading.
