The proposal is regarding permission for laying of Underground Sewage Pipeline along the road from Km.156+260 to Km.156+420 (LHS), Km.156+260 to Km.156+580 (RHS), Gravity Sewer - Km.156+410 to Km.156+600 (LHS), Km.157+535 to Km.157+565 (LHS), Km.157+535 to Km.157+780 (RHS), Km.159+173 to Km.160+170 (RHS), Gravity Sewer - Km.159+870 to Km.160+160 (RHS), Km.159+658 to Km.159+708 (LHS), Km.159+173 to Km.159+708 (RHS) and Across the road at Km.154+300, Km.156+260, Km.157+535 and Km.159+708 of Madurai - Kanyakumari Section of NH-44 (Old No. NH-7) in the state of Tamil Nadu submitted to this office by PD, PIU, Madurai vide Lr.No. NHAI/PIU/MDU/NH-7/Utility/2021/2506, dt.08.09.2021 in accordance with Ministry's latest guideline dated 22.11.2016.

The alignment proposed by the Commissioner, Tirunelveli Corporation, Tirunelveli for laying underground Sewage pipeline along the road from Km.156+260 to Km.156+420 (LHS), Km.156+260 to Km.156+580 (RHS), Gravity Sewer - Km.156+410 to Km.156+600 (LHS), Km.157+535 to Km.157+565 (LHS), Km.157+535 to Km.157+780 (RHS), Km.159+173 to Km.160+170 (RHS), Gravity Sewer - Km.159+870 to Km.160+160 (RHS), Km.159+658 to Km.159+708 (LHS), Km.159+173 to Km.159+708 (RHS) and Across the road at Km.154+300, Km.156+260, Km.157+535 and Km.159+708 in Madurai - Kanyakumari section of NH-7 in the state of Tamil Nadu i.e., in a length of 2817m as detailed under;

3. The Right of Way is 60 m in the aforesaid stretch. The proposed laying underground Sewage pipeline along the road from Km.156+260 to Km.156+420 (LHS), Km.156+260 to Km.156+580 (RHS), Gravity Sewer - Km.156+410 to Km.156+600 (LHS), Km.157+535 to Km.157+565 (LHS), Km.157+535 to Km.157+780 (RHS), Km.159+173 to Km.160+170 (RHS), Gravity Sewer - Km.159+870 to Km.160+160 (RHS), Km.159+658 to Km.159+708 (LHS), Km.159+173 to Km.159+708 (RHS) and Across the road at Km.154+300, Km.156+260, Km.157+535 and Km.159+708 in Madurai - Kanyakumari section of NH-7 in the state of Tamil Nadu for a length of 2817m. Further, the Commissioner, Tirunelveli Corporation, Tirunelveli has given undertaking that the lay of underground Sewage pipeline is proposed to lay by **HDD Method** at a depth of 1.55m distance to the casing pipe from the top of the sub grade which is in conformity with Ministry's latest guidelines dated 22.11.2016.

4. The applicant has furnished an undertaking that they will shift the laid underground Sewage pipeline in future when required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed laying of underground Sewage pipeline work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
