The proposal is regarding permission for Erection of 11 KV overhead electrical line along the road from Km.89/750 to Km.92/015 (RHS) in Madurai - Kanyakumari section of NH-7 in the state of Tamil Nadu submitted to this office by PD, PIU, Madurai vide Lr.No. NHAI/PIU/MDU/NH-7/Utility/2021/788, dt.16.03.2021 in accordance with Ministry's latest guideline dated 22.11.2016.

2. The alignment proposed by M/s. KGiSL Infrastructure Private Limited, Coimbatore for Erection of 11 KV overhead electrical line along the road from Km.89/750 to Km.92/015 (RHS) in Madurai - Kanyakumari of NH-7 in the State of Tamil Nadu i.e., 2265 m as detailed under:
