The proposal is regarding permission for laying of water Pipeline across the road at Km.14+331 of Melur to Karaikudi section of NH-338, 383 & 38 in the State of Tamil Nadu submitted to this office by PD, PIU, Madurai vide Lr.No. NHAI/PIU/MDU/NH-38, 383, 338/Utility/2021/3184, dt.05.11.2021 in accordance with Ministry's latest guideline dated 22.11.2016.

2. The alignment proposed by the Executive Engineer, TWAD Board, Project Division, Sivagangai for laying of water pipeline across the road at Km.14+331 of Melur to Karaikudi section of NH-338, 383 & 38 in the State of Tamil Nadu as detailed under;

3. The Right of Way is 60 m in the aforesaid stretch. The proposed laying water pipeline across at Km.14+331 of Melur to Karaikudi section of NH-338, 383 & 38 in the State of Tamil Nadu executed by the Executive Engineer, TWAD Board, Project Division, Sivagangai. Further, Executive Engineer, Sivagangai has given undertaking that the laying of water pipeline is proposed to lay by **HDD Method** at a depth of

2.60m distance to the casing pipe from the top of the sub grade which is in conformity with Ministry's latest guidelines dated 22.11.2016.

4. The applicant has furnished an undertaking that they will shift the laid underground Sewage pipeline in future when required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed laying of underground Sewage pipeline work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

5. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29 /2015/S&R(R) dated 22.11.2016, the application submitted by the applicant will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
