Sub: NHAI, Madurai Region - PIU, Madurai - Operation and Maintenance of Madurai - Kanyakumari section from Km.0/000 to Km.243/170 of NH-7 in the State of Tamil Nadu - Permission for laying of Water Pipeline along the road from Km.50+450 to Km.50+850 (RHS), Km.77+500 to Km.79+130 (RHS), Km.78+100 to Km.79+130 (LHS) & Km.80+500 to Km.80+800 (LHS) and Across the road at Km.50+450, Km.78+100, Km.78+250 & Km.78+710 of Madurai - Kanyakumari Section of NH-44 (Old No. NH-7) - Proposal submitted - Reg.

The proposal is regarding permission for laying of Water Pipeline along the road from Km.50+450 to Km.50+850 (RHS), Km.77+500 to Km.79+130 (RHS), Km.78+100 to Km.79+130 (LHS) & Km.80+500 to Km.80+800 (LHS) and Across the road at Km.50+450, Km.78+100, Km.78+250 & Km.78+710 of Madurai - Kanyakumari Section of NH-44 (Old No. NH-7) in the state of Tamil Nadu submitted to this office by PD, PIU, Madurai vide Lr.No. NHAI/PIU/MDU/NH-7/Utility/2021/3202, dt.09.11.2021 in accordance with Ministry's latest guideline dated 22.11.2016.

2. The alignment proposed by the Executive Engineer, TWAD Board, Project Division, Sattur for laying of Water pipeline along the road from Km.50+450 to Km.50+850 (RHS), Km.77+500 to Km.79+130 (RHS), Km.78+100 to Km.79+130 (LHS) & Km.80+500 to Km.80+800 (LHS) and Across the road at Km.50+450, Km.78+100, Km.78+250 & Km.78+710 of Madurai - Kanyakumari Section of NH-44 (Old No. NH-7) in the state of Tamil Nadu i.e., in a length of 3360m as detailed under;

Kanyakumari section of NH-7 in the state of Tamil Nadu for a length of 3360m. Further, the Executive Engineer, TWAD Board, Project Division, Sattur has given undertaking that the lay of underground Sewage pipeline is proposed to lay by **HDD Method** at a depth of 1.55m distance to the casing pipe from the top of the sub grade which is in conformity with Ministry's latest guidelines dated 22.11.2016.

4. The applicant has furnished an undertaking that they will shift the laid underground Sewage pipeline in future when required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed laying of underground Sewage pipeline work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

5. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29 /2015/S&R(R) dated 22.11.2016, the application submitted by the applicant will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
