Sub: NHAI, Madurai Region - PIU, Madurai - Operation and Maintenance of Madurai - Kanyakumari section from Km.0/000 to Km.243/170 of NH-7 in the State of Tamil Nadu - Permission for laying of Airtel OFC Cable from Km.99/900 to Km.102/000 (RHS), from Km.177/200 to Km.189/400 (LHS), from Km.189/400 to Km.189/700 (RHS) and crossing at Km.177/450, Km.177/500 and Km.189/400 of Madurai - Kanyakumari section of NH-7 - Proposal submitted - Reg.

The proposal is regarding permission for laying underground Optical Fibre Cable along the road from Km 99/900 to Km.102/000 (RHS), from Km.177/200 to Km.189/400 (LHS), from Km.189/400 to Km.189/700 (RHS) and crossing at Km.177/450, Km.177/500 in Madurai - Kanyakumari section of NH-7 in the state of Tamil Nadu submitted to this office by PD, PIU, Madurai vide Lr.No. NHAI/PIU/MDU/NH-7/OFC/2020/3242, dt.21.12.2020 in accordance with Ministry's latest guideline dated 22.11.2016.

2. The alignment proposed by the applicant M/s. Telesonic Network Limited, Chennai for laying Optical Fibre Cable along the road from Km 99/900 to Km.102/000 (RHS), from Km.177/200 to Km.189/400 (LHS), from Km.189/400 to Km.189/700 (RHS) in Madurai - Kanyakumari of NH-7 in the State of Tamil Nadu i.e. in a length of 14,600 m as detailed under:

3. The Right of Way is 60 m in the aforesaid stretch. The proposed Optical Fibre Cable along the roads from Km 99/900 to Km.102/000 (RHS), from Km.177/200 to Km.189/400 (LHS), from Km.189/400 to Km.189/700 (RHS) for a length of 14600m. Further, the applicant M/s. Telesonic Network Limited, Chennai has given undertaking that the lay of Optical Fibre Cable is proposed to lay by **HDD Method** at a depth of 1.65m distance to the casing pipe from the top of the sub grade which is in conformity with Ministry's latest guidelines dated 22.11.2016.

4. The applicant has furnished an undertaking that they will shift the laid Optical Fibre Cable in future when required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed laying of Optical Fibre Cable work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

5. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29 /2015/S&R(R) dated 22.11.2016, the application submitted by the applicant will be made available for public comments and the comments will be invited within 30 days from the date of uploading.
