Sub: NHAI, Madurai Region - PIU, Trichy - Permission for laying of water supply pipeline along NH from Km 20/460 to Km 20/510 (LHS) and across NH at Km 20/460 providing water supply to M/s KALS BREWERIES Pvt Ltd., in Trichy-Madurai section of NH-45B in the State of Tamil Nadu - Proposal submitted - Reg

The proposal regarding permission for laying of water supply pipeline along NH from Km 20/460 to Km 20/510 (LHS) and across NH at Km 20/460 providing water supply to M/s KALS BREWERIES Pvt Ltd., in Trichy-Madurai section of NH-45B in the State of Tamil Nadu submitted to this office vide PD Trichy Lr. No. NHAI/PD/TRY/TWAD/NH-45B//T-M/2020/494 dated 31.07.2020 in accordance with Ministry's latest guidelines dated 22.11.2016.

2. The alignment proposed by the Executive Engineer, TWAD Board, Project Division, Pudukottai for laying of water supply pipeline along NH from Km 20/460 to Km 20/510 (LHS) and across NH at Km 20/460 in Trichy-Madurai section of NH-45B in the State of Tamil Nadu i.e. in a length of 50 m as detailed under:

3. The right of way varies from 59 to 60m in the aforesaid stretch. The Executive Engineer, TWAD Board, Project Division, Pudukottai has proposed to lay the water supply pipeline at the extreme edge of the ROW for a length of 50 m. Further, the Executive Engineer, TWAD Board, Project Division, Pudukottai has given undertaking that the lay of water supply pipeline is proposed to lay by **Open Trench Method** at a depth of 1.15 m from the bottom of the ground and a crossing at Km 20/460 by HDD Method for a distance of 59 m at a depth of 1.60 m which is in conformity with Ministry's guidelines.

4. The Executive Engineer, TWAD Board, Project Division, Pudukottai has furnished an undertaking to the effect that they will remove the laid of water supply pipeline in future if required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed laying of water supply pipeline work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

5. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the application submitted by the applicant will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
