Please refer to the letter under reference (2) vide which it has been requested by RO-MoRT&H, Kolkata to examine the proposal and specific comments keeping in view proposed ROW required in connection with Bharatmala Pariyojana and calculation license fee.

In this regard PD - PIU - Durgapur has intimated the following vide his letter at ref(1):

- The proposal was put up in PIU by POWERGRID. Accordingly, the proposal was jointly verified at site by PIU with representatives of POWERGRID and it was found that the same is not conflicting with the upcoming 2-laning with paved shoulder project of NH-32 to be executed by NHAI. However, since the stretch was not handed over to NHAI till that time, therefore, the proposal was forwarded in original to the Executive Engineer, NH Division-IV, NH Wing, P.W. (Roads) Directorate, Govt. of West Bengal, under whose jurisdiction the concerned stretch of NH-32 falls, for taking further necessary action from their end. Accordingly, the proposal has been processed by the P.W. (Roads) Directorate, Govt. of West Bengal for according permission of the MoRT&H.
- Regarding the License Fee, it is to mention that the Tower/supporting system will not come inside the PROW at the location and therefore, as per Clause 5.2 of MoRT&H guidelines dated 22.11.2016, license fee will not be applicable.
- All papers / documents have been examined and found in order in light of the MoRT&H's circular no. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016.

In view of the above, the proposal is forwarded herewith for taking further necessary action from your end.
