Reference may please be made to your letter under reference wherein the proposal for granting permission to accommodating/laying of water pipe line utility services on National Highway has been forwarded to this office for verification w.r.t. Ministry's guidelines dt.22.11.2016.

2. The proposal has been examined in compliance with the guidelines of Ministry vide Circular No.RW/NH-33023/29/2015/S&R(R) dt.22.11.2016.

3. The following documents were submitted by the applicant:-

- Dully filled in check list.
- Signed copies of Agreement regarding granting of ROW permission for laying utility services on National Highways, 05 Nos. of Undertakings, Affidavit-1 No.
- A certified copy of layout plans showing the route and crossing of water pipeline including details of crossing.
- The agency has furnished an undertaking of Rental that the agency will pay necessary fee for the use of National Highway land whenever the fee is asked by the Highway Authorities in future and undertaking that the agency shall shift the utility

services within 90 days from the date of issue of the notice by the Concerned Authority to shift/relocate the Utility services in case it is so required for the purpose of improvement/widening of the road/route-Highway or construction of flyover/bridge and restore the road/land to its original condition at his own cost and risk.

- (v) The agency has furnished an undertaking that water pipeline would be laid keeping in mind future expansion of 4/6 lane of the National Highway and shall provide safety measures like barricading, danger lighting and other necessary caution boards while executing the work.
- (vi) The agency has furnished an undertaking that they shall lay the water pipeline under the guidance of the department and the department shall not be responsible, in case the water pipeline comes in the area under development in future at any time. In such an eventually shifting of the water pipeline etc. shall be the liability of Municipal Corporation, Rajnadgaon, C.G.
- (vii) The agency has furnished an undertaking that in the event of any mis-happening/accidents etc. while laying water pipeline shall be liable to pay any type of compensation so claimed and shall not cause any damage to the carriageway of the highway structure like bridge, culvert, drain, building etc. and in case of failure Municipal Corporation, Rajnadgaon, C.G., shall be liable to make good the loss caused to the department .

4. The applicant has proposed the crossing of water pipeline on NH-53(Old NH-6) at Ch:340+229 to Ch:341+040(RHS) parallel to the service road & crossing of water pipeline at three locations i.e.Ch:341+500,342+515 & 343+817. The crossing of NH at the three locations shall only be carried out by HDD(Horizontal Directional Drilling) method. The corrections marked on drawing with red ink may kindly be noted.

5. In view of the above, the proposal is forwarded along with all documents for further necessary action at your end as per MoRT&H Circular No. RW/NH-33023/29/2015/S&R(R) dt.22.11.2016.

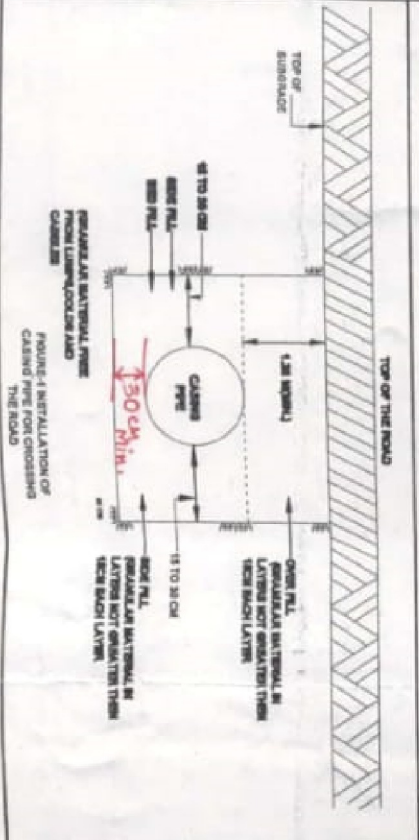
