Invitation of Public Comments

Sub: NHAI, RO Chennai - PIU - Salem - Laying of Irrigation Water Pipe Line along the road from Km 36/735 to Km 36/770 (RHS), Km 36/815 to Km 36/845 (RHS), Km 38/970 to Km 38/995 (RHS) & Km 38/970 to Km 38/995 (LHS) and across @ Km 36/735, Km 36/845 & Km 38/970 of NH 544 (Salem to Kumarapalayam section) for the total length of 115m by Sri Mangamalaiayar Lift Irrigation Farmers Association, Sangari Taluk, Salem District - Approval Requested - Reg.

- 1. The subject proposal requesting permission for laying of 250mm dia PVC pipe with 380mm HDPE Casing pipe at Km 36/735 to Km 36/770, 150mm PVC pipe along with 300 mm HDPE casing pipe at Km 36/815 to Km 36/845 & 230 mm PVC pipe with 380mm HDPE casing pipe in the utility corridor from Km 38/970 both (LHS & RHS) for a length of 50m and Three numbers Road Crossing at Km 36/735, Km 36/845 & Km 38/970 of minimum 1.65m depth below the ground level by HDD method in the Project highway of Salem to Kumarapalayam section of NH-544 in the State of Tamil Nadu.
- 2. The available width of ROW is 60m (30 + 30) and it is proposed to lay the pipeline in the utility corridor and one number road crossing
- 3. M/s. Sri Mangamalaiyar Lift Irrigation Farmers Association, Salem has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. Sri Mangamalaiyar Lift Irrigation Farmers Association, Salem will be made available for
