Invitation of Public Comments

Sub: NHA, RO Chennai - PIU - Salem - Proposal for Laying of Water Pipe Line Along the road from Km 216/293 to Km 216/703 (RHS) & across @ Km 216/293 of NH-7 (Thumbipadi to Namakkal section) for the total length of 0.410 Km by the Executive Engineer, TWAD Board, RWS Division, Namakkal - **Approval Requested - Reg.**

1. The subject proposal is requesting permission for laying of Underground 500mm Dia Water pipeline along the utility corridor from Km 216/293 to 216/703 (RHS) by Open Trench Method for a length of 410m along the road and one number Road Crossing at Km 216/293 of minimum 1.65m depth below the ground level by HDD method in the Project highway of (Thumbipadi to Namakkal section) of NH-544 in the State of Tamil Nadu.
2. The available width of ROW is 60m (30 + 30) and it is proposed to lay the pipeline in the utility corridor and one number road crossing
3. M/s. TWAD Board, Nmakkal has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHA considers if necessary in future, it will be carried out as desired by the NHA at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHA.
4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. TWAD Board, Tiruppur will be made available for 30 days seeking public

comments/objection and shall be furnished within 30 days from the day of closure of public objections.
