Invitation of Public Comments

Sub: NHAI, RO Chennai - PIU - Kancheepuram - Proposal for Laying of Water Pipe Line across the road at Km 98/423 by the M/s Tamil Nadu Water Supply and Drainage Board, Ranipet - Approval Requested - Reg.

- 1. The subject proposal is requesting permission for 400mm Dia Water pipeline across the utility corridor at Km 98/423 by Trenchless Method and 1.5m depth below the ground level by Trenchless method in the Project highway of (Karaipettai to Walajapet section) of NH-4 in the State of Tamil Nadu.
- 2. The available width of ROW is 60m (30 + 30) and it is proposed to lay the pipeline in the utility corridor.
- 3. M/s Tamil Nadu Water Supply and Drainage Board, Ranipet, has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. State Industries Promotion Corporation of Tamilnadu Ltd, Erode will be made available for 30 days seeking public comments/objection and shall be furnished within 30 days from the day of closure of public objections.
