Invitation of Public Comments

Sub: NHAI, RO Chennai - PIU - Salem - Proposal for Laying of Water Pipe Line Along the road from Km 16/600 to Km 16/980 (RHS) & Km 16/840 to Km 16/980 (LHS) and across @ Km 16/980 of NH-47 (Salem to Kumarapalayam section) for the total length of 520m by the Executive Engineer, TWAD Board, RWS Division, Namakkal - Approval Requested - Reg.

- 1. The subject proposal is requesting permission for laying of Underground 500mm Dia Water pipeline along the utility corridor from Km 16/600 to 16/980 RHS by Trench Method for a length of 520 m along the road and one number Road Crossing at Km 16/980 of minimum 1.65m depth below the ground level by HDD method in the Project highway of Salem to Kumarapalayam section of NH-544 in the State of Tamil Nadu.
- 2. The available width of ROW is 60m (30 + 30) and it is proposed to lay the pipeline in the utility corridor and one number road crossing
- 3. M/s. TWAD Board, Namakkal has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. TWAD Board, Namakkal will be made available for 30 days seeking public comments/objection. and shall be furnished within 30 days from the day of closure of public objections.
