Sub: Proposal for access permission for approach roads at km 272/200 to 272/240 (LHS) on NH-59 to the proposed Retail Outlet of Shri Budhiram Behera (applicant of IOCL) at Mouza-Sana Surada, Ps/Tahasil-Surada, Dist-Ganjam in the state of Odisha-reg.

- 1. Shri. Budhiram Behera (applicant of IOCL), i.e., the applicant, vide letter dated 29.05.2020 has submitted a proposal to this office on the above mentioned subject. The applicant is requesting relaxation from Ministry's guideline issued vide letter no. RW/NH-33023/19/99-DO.III dated 24.07.2013 with respect to the "Distance from Check barrier/Toll Plaza/Railway level crossing" is at a distance of 380 m from the proposed Retail Outlet against the norm of minimum distance 1000 m.
- 2. As per Ministry's OM No. RW/NH/33023/19/99/DO-III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal along with Form-A on the Ministry's website (morth.nic.in) to invite public comments, for a period of 60 days.
- 3. In view of the above, comments of public, if any, on the above relaxation proposal are invited online as well as in hard copy by enclosing location plan, justification & Form-A. The same should reach to the below mentioned address within 60 days from the date of uploading it, in the website, beyond which no objection will be considered.


