3. There is total BE outlay of ₹ 4555 crore under Maintenance and Repairs Scheme for the financial year 2025-26. An amount of Rs.80 crore has been allocated/released to NHIDCL, Rs.75 crore to BRO and Rs.571 crore to State PWD, ₹ 3129 crore shall be in reserve/balance in the head of account.

4. The claims would be entertained as per revised procedure vide this Ministry's letter No. RW/G-20011/2/2001-W&A dated 12.4.2001.

5. The amount should be spent for the schemes sanctioned under the head indicated in para 2 only. No expenditure should be booked/ incurred above the financial limit prescribed in each sanctioned job.


