2. The above amount/expenditure is debit to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2025-26:-

- 5054 - Capital Outlay on Roads & Bridges (Major Head)
- 01 - National Highways (Sub Major Head)
- 01.337 - Road Works (Minor Head)
- 05 - Special Accelerated Road Development Programme in North Eastern Areas financed from National Investment Fund
- 05.00 - Special Accelerated Road Development Programme in North Eastern Areas financed from National Investment
- 05.00.73 - Infrastructural Assets

3. Out of total BE allocation of ₹ 966.00 crore under SARDP-NE for the financial year 2025-26, an amount of ₹ 230.00 crore has been allocated to States/UTs. After release of this sanction letter of ₹300.00 crore to NHIDCL (total ₹450.00 crore), an amount of ₹ 286.00 crore is reserve/balance in the head of account SARDP-NE.

4. It shall be ensured that the expenditure against above sanction is incurred only on the works sanctioned by the Ministry under SARDP-NE.

5. The accounts of National Highways & Infrastructure Development Corporation Ltd. (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.




