**Sub:** State-wise revised allocation of funds for incurring expenditure on the implementation of work sanctioned under LWE-TSP Scheme on purely first-come-first-serve-basis during the financial year 2022-23-reg.

## Sir,

In continuation of this Ministry's letter of even number dated 18<sup>th</sup> January, 2023, I am directed to convey the sanction of the President to allow ROs/RPAOs to admit expenditure against sanctioned **LWE-TSP works** (Head 5054.01.796.01.01.53 (Tribal Sub Plan under LWE Scheme) on purely **First-come-First-serve basis** henceforth during Financial Year 2022-23 out of the total overall **revised allocation of Rs.340.00 crore (Rupees three hundred and forty crore only)** for States/UTs/PIUs, subject to the condition that office of Principal CCA shall ensure that overall expenditure for LWE-TSP is not exceeded at any point of time as these would ensure that bills pertaining to well performing States are cleared without any delay and there is no gestation period involved on account of the requirement to enhance their outlay at any stage in case the States/UTs/PIUs allocation is/are fully exhausted as long as the total outlay of LWE-TSP for States/UTs/PIUs for entire Country is not fully exhausted.

2. The expenditure is debitable to the above head under Demand No. 86 – Ministry of Road Transport & Highways for the year 2022-23.

3. The works under LWE schemes are to be implemented on the pattern of National Highway Works and Direct Payment Procedure as being adopted for NH works.

4 . While entertaining the claims on the basis of allocation referred to above, it may please be ensured that:-

- Expenditure is incurred only on sanctioned works (NHs and State Roads) in LWE affected area only.
- 2. No claim is entertained for expenditure incurred on any sanctioned works in excess of the sanctioned cost beyond permissible limits.
- 3. No expenditure is admitted on work/portion of the work where it might have been specifically advised not to incur any expenditure pending receipt/approval of certain issues/points, etc.
